BTY Coin (Beauty Coin) Whitepaper

1. Executive Summary

BTY Coin (Beauty Coin) is a token system originating from the beauty industry built on DIVER Chain. Going beyond a mere point program, it realizes a chain-circular platform that seamlessly connects various industries including beauty, nail care, fashion, and related fields.

We support the realization of a richer lifestyle by not limiting users' aesthetic experiences to a single closed environment, but by naturally chaining them to various related services and products.

2. Background and Challenges

Currently, beauty-related services are provided independently, fragmenting the user experience. For example, changing a hairstyle does not seamlessly connect to nail design choices or fashion purchases, and each is treated as an independent decision.

Additionally, each service provider operating their own point system creates the following challenges:

- User behavior data is fragmented, preventing optimal recommendations
- Limited uses for acquired points
- Difficulty in coordination between service providers
- Restricted access to professional products

3. BTY Coin Solution: Chain-Circular Platform

3.1 Overview and Technical Specifications

BTY Coin is implemented as a DRC20 standard token on DIVER Chain, equipped with smart contract auto-execution functions. Token allocation assigns 92% to DEX IDO and 8% to development/operation pools, ensuring market liquidity and sustainable development.

3.2 Chain Value Exchange System

BTY Coin enables chain value exchanges centered on beauty experiences:

- Beauty Block
 - Service use at hair salons
 - Treatments at esthetic and eyelash salons
 - Exchange for professional beauty products
 - Purchase of customized hair care products

- Nail & Body Care Block
 - Booking treatments at nail salons
 - Use of body care services
 - Exchange for professional nail products
 - Obtaining personalized care products
- Fashion Block
 - Styling coordination consultation
 - Private shopping reservations
 - Priority access to limited items
 - Custom order item production requests

3.3 Cross-Industry Development

BTY Coin's value exchange is not limited to beauty-related industries:

- Mutual exchange with other industry-specific coins (such as Food Coin)
- Collaboration with different industry services (cafes, restaurants, fitness, etc.)
- Realization of seamless experiences across all lifestyle aspects

4.1 Value Circulation Flow

1. Experience Chain

Changes in hairstyle prompt nail design choices, which further lead to fashion suggestions matching these choices, creating a natural chain of aesthetic experiences.

2. Data Circulation

Choices and experiences in each service become valuable information for the next service provider, enabling more appropriate recommendations.

3. Value Circulation

Acquired tokens can be exchanged for various services and products, and their use leads to further token acquisition, creating a sustainable circulation.
